



Performance Curves




Fig1. Forward Voltage Drop vs Forward Current




Fig3. Reverse Recovery Current vs di_F/dt




Fig2. Reverse Recovery Time vs di_F/dt




Fig4. Reverse Recovery Charge vs di_F/dt
