





$S_{rel} = f(\varphi)$


















### Power Consumption

## Dimensional Drawing <sup>5)</sup>







### Recommended Solder Pad <sup>5)</sup>




Component Location on Pad



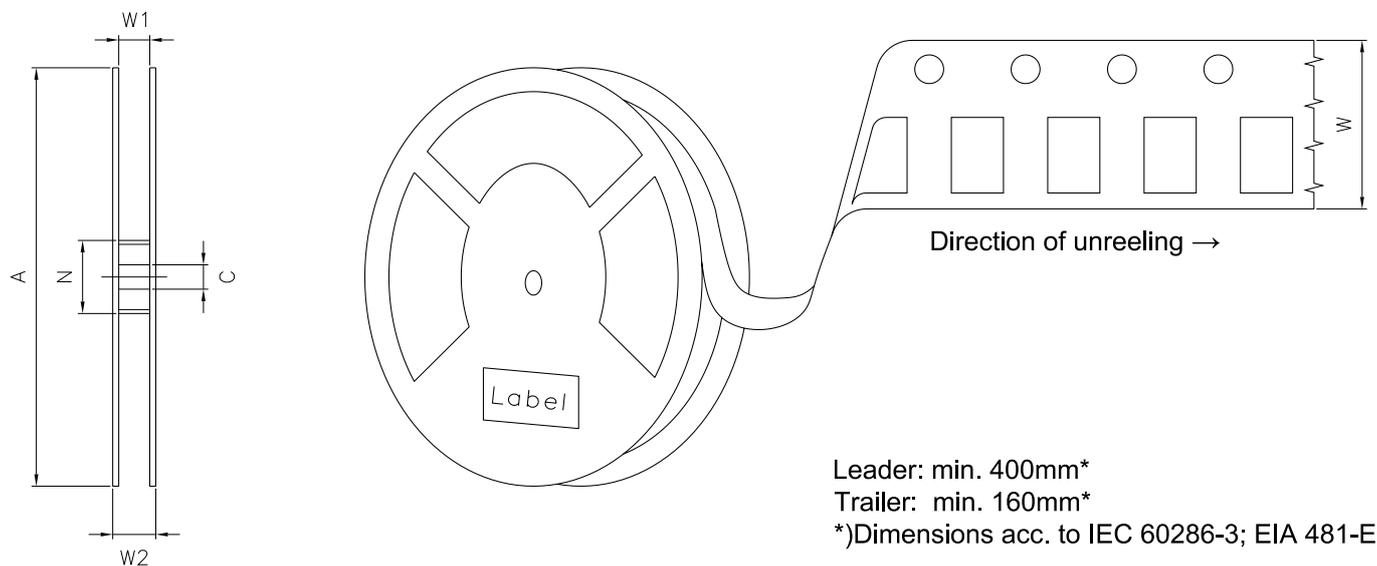



## Notes
